

NOTICE OF CORRECTION

The publication on March 3, 2006 of Resolution No. R-06-101 of the City of Wichita, Kansas regarding the advisability of constructing pavement on Churchill and Churchill Court (East of 127th Street East, South of 21st) 472-84384 contained an error in the Heading and Section 1. The Heading and Section 1 should have read as follows:

RESOLUTION OF FINDINGS OF ADVISABILITY AND RESOLUTION AUTHORIZING CONSTRUCTING PAVEMENT ON **CHURCHILL FROM THE SOUTH LINE OF LOT 1, BLOCK 2, TO THE SOUTH LINE OF LOT 12, BLOCK 2; PAVING CHURCHILL COURT, SERVING LOTS 4 THROUGH 9, BLOCK 2, FROM THE SOUTH LINE OF CHURCHILL TO AND INCLUDING THE CUL-DE-SAC (EAST OF 127TH ST. EAST, SOUTH OF 21ST) 472-84384** IN THE CITY OF WICHITA, KANSAS, PURSUANT TO FINDINGS OF ADVISABILITY MADE BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS.

BE IT RESOLVED BY THE GOVERNING BODY OF THE CITY OF WICHITA, KANSAS, THAT THE FOLLOWING FINDINGS AS TO THE ADVISABILITY OF CONSTRUCTING PAVEMENT ON **CHURCHILL FROM THE SOUTH LINE OF LOT 1, BLOCK 2, TO THE SOUTH LINE OF LOT 12, BLOCK 2; PAVING CHURCHILL COURT, SERVING LOTS 4 THROUGH 9, BLOCK 2, FROM THE SOUTH LINE OF CHURCHILL TO AND INCLUDING THE CUL-DE-SAC (EAST OF 127TH ST. EAST, SOUTH OF 21ST) 472-84384** IN THE CITY OF WICHITA, KANSAS, ARE HEREBY MADE TO-WIT:

SECTION 1. That it is necessary and in the public interest to authorize constructing pavement on **Churchill from the south line of Lot 1, Block 2, to the south line of Lot 12, Block 2; paving Churchill Court, serving Lots 4 through 9, Block 2, from the south line of Churchill to and including the cul-de-sac (east of 127th St. East, south of 21st) 472-84384.**

Said pavement shall be constructed of the material in accordance with plans and specifications provided by the City Engineer.
