ORDINANCE NO. 48-342

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN
BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE
LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS.
(A09-06)

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,
KANSAS:

SECTION 1. The governing body, under the authority of K.S.A. 12-519, et seq, hereby annexes the following blocks, parcels, pieces and tracts of land and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas and designated as being part of City Council District IV respectively:

All of Lot 1, St. Peter The Apostle Catholic Church Addition to Sedgwick County, Kansas, located in the SE/4 & SW/4 of S7-T28S-R1W; EXCEPT that part described as follows: Beginning at the most southerly SE Corner of Said Lot 1, said corner also being the SE Corner of Lot 1, Block A, Schulte Country Store Addition, Sedgwick County, Kansas; thence northerly along the line common to said St. Peter The Apostle Catholic Church and Schulte Country Store Addition. 95.51 feet, more or less, to a point 68.31 feet south of NE corner of Schulte Country Store Addition, thence southeasterly, 80.79 feet to a point on the south line of said St. Peter the Apostle Catholic Church Addition; thence southwesterly along the south line of said St. Peter the Apostle Catholic Church, being a curve to the left, having a central angle of 0 degrees 9'7" and a radius of 19158.61 feet, an arc distance of 50.84 feet, to the point of beginning.

AND

Lot 1, Block A, St Peter the Apostle Catholic Church 2nd Addition to Sedgwick County, Kansas located in the SE/4 of S7-T28S-R1W.

AND

Schulte Country Store Addition to Sedgwick County, Kansas located in the SE/4 of S7-T28S-R1W.

AND

Schulte Country Storage Addition to Sedgwick County, Kansas located in the SE/4 of S7-T28S-R1W.

SECTION 2. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void, then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 3. That the City Attorney be and he is hereby instructed at the proper time to draw a resolution redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517, et seq.

SECTION 4. This ordinance shall become effective and be in force from and after its adoption and publication once in the official city paper.
