PROS ADVISORY COMMITTEE MEETING #2
MAY 17, 2007
MEETING SUMMARY

PROS Advisory Committee members met on Thursday, May 17th in City Hall to discuss issues related to the Parks, Recreation, and Open Space Planning Process. The meeting was led by Lauren Schmitt, of MIG, Inc, who began by updating the Committee on work to date. Ms. Schmitt's introduction included a presentation of major findings regarding the planning context and the existing conditions of the Wichita parks, recreation, and open space system.

In thinking of ways to position parks and recreation in Wichita, the Committee identified a number of problems that parks and recreation can help solve, including:

- Environmental issues, such as water and air quality and flooding
- Space and design issues
- Neighborhood deterioration
- Youth issues
- Chronic disease and other health concerns
- Poverty and lack of access to opportunities
- Lack of community

The discussion of the Park and Recreation Department's role in park and recreation service provision centered largely on the tension between providing something for everyone and focusing the approach. During the course of the meeting, Committee members identified numerous roles for the Department:

- Coordinator of programming and facilities
- Provider for low-income families
- Provider for youth
- Planner
- Mediator between different user groups
- Revenue generator
- Developer of community
- Continuous monitor of maintenance issues, user groups, and public needs
- Provider for built out areas
- Provider of neighborhood-based services.

A number of overarching issues surfaced during the meeting, including the following:

- Identifying needs and defining the extent of stakeholder groups
- Equity and mediating between the needs of different stakeholder groups
- Maintaining and building relationships as populations and user groups change
- Access for people without transportation and low-income communities
- Developing new funding mechanisms
- Planning, building, and paying for maintenance

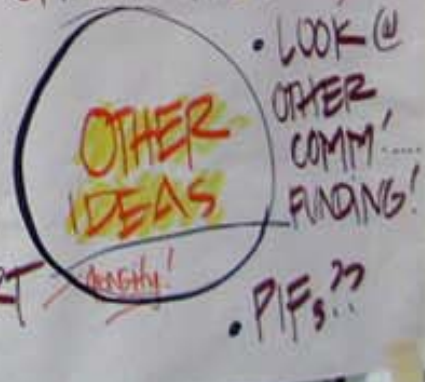
