AMENDMENT TO AGREEMENT DATED JUNE 26, 1973 AS AMENDED BETWEEN THE BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, AND THE CITY OF WICHITA, KANSAS PURSUANT TO A JOINT RESOLUTION/ORDINANCE CREATING THE WICHITA-SEDGWICK COUNTY METROPOLITAN AREA PLANNING COMMISSION.

THIS Amendment to AGREEMENT, made and entered into this 9th day of OCTOBER, 1991, by and between the CITY OF WICHITA, KANSAS, hereinafter referred to as "City", and the BOARD OF COUNTY COMMISSIONERS OF SEDGWICK COUNTY, KANSAS, hereinafter referred to as "County".

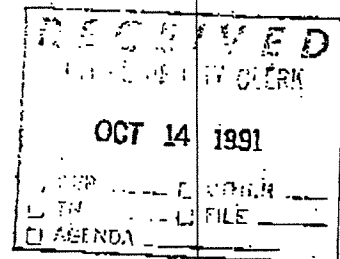
WITNESSETH:

WHEREAS, K.S.A. 12-716 et seq., allows a city and county to jointly cooperate in the exercise and performance of planning powers, duties and functions through the creation of a metropolitan planning commission; and

WHEREAS, the parties hereto, on December 6, 1967, adopted Joint Ordinance No. 29-610 of the City of Wichita and Resolution No. 135-1967 of Sedgwick County, Kansas, creating the Wichita-Sedgwick County Metropolitan Area Planning Commission; and

WHEREAS, the parties hereto previously entered into an agreement on the 26th day of June, 1973; and

WHEREAS, on the 29th day of December, 1988, the parties hereto amended Section 1 of said Agreement, entitled "Membership, Term, Qualification, Compensation"; and



WHEREAS, the parties hereto now desire to further amend said Section 1 of said Agreement.

NOW, THEREFORE, the parties do hereby agree that Section 1 entitled "Membership, Term, Qualifications, Compensation" of the joint agreement between the parties dated June 26, 1973, as amended by the agreement dated the 29th of December, 1988, is hereby further amended to read as follows:

"SECTION 1. MEMBERSHIP, TERM, QUALIFICATIONS, COMPENSATION. The Wichita-Sedgwick County Metropolitan Area Planning Commission shall consist of fourteen (14) members, seven (7) of whom shall be appointed by the City of Wichita, and seven (7) of whom shall be appointed by a majority vote of the Board of County Commissioners of Sedgwick County, upon the recommendation of individual County Commissioners.

Appointments made by the City of Wichita shall be in conformity with Section 2.12.020(1) of the City Code and as amended; provided, however, that current members shall continue to serve until their present terms expire.

Appointments made by the Board of County Commissioners of Sedgwick County shall be for a period of four years commencing upon the date of final passage of this Agreement, except that members currently serving on the Metropolitan Area Planning Commission shall continue to serve until the expiration of their term as set out in

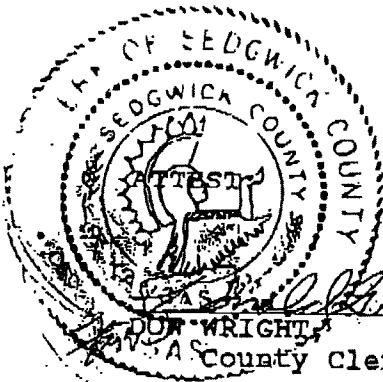
their appointing resolutions. Members appointed following final passage of this Agreement shall serve at the pleasure of the Board of County Commissioners and in the event the Commissioner recommending the appointment of said members leaves office for any reason said term shall expire, except that a member so appointed may continue to serve until a successor has been duly appointed. A vacancy shall be filled for the unexpired term of the member in the same manner as the original appointment.

Any person residing in the City of Wichita shall be eligible for appointment by the City of Wichita. Any person residing within Sedgwick County (including incorporated areas) shall be eligible for appointment by the Board of Commissioners of Sedgwick County. Members of the Wichita-Sedgwick County Metropolitan Area Planning Commission shall serve without compensation, but may be reimbursed for expenses actually incurred in the performance of their duties as members of the commission."

The remaining sections of the joint agreement between the parties dated June 26, 1973, shall continue in full force and effect as written therein.

This amendment shall be effective upon its execution by both the City Council of the City of Wichita and the Board of County Commissioners of Sedgwick County, Kansas.




