

## ORDINANCE NO. 46-185

AN ORDINANCE INCLUDING AND INCORPORATING CERTAIN  
BLOCKS, PARCELS, PIECES AND TRACTS OF LAND WITHIN THE  
LIMITS AND BOUNDARIES OF THE CITY OF WICHITA, KANSAS.  
(A 04-15)

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF WICHITA,  
KANSAS:

SECTION 1. The governing body, under the authority of K.S.A. 12-519, et seq, hereby annexes the following blocks, parcels, pieces and tracts of land and they are hereby included and brought within the corporate limits of the City of Wichita, Kansas and designated as being part of [City Council District V](#) respectively:

That part of the S 1/2 of the S 1/2 of the N 1/2 of the SE 1/4 of Sec. 28, Twp. 26-S, R-1-W of the 6<sup>th</sup> P.M., Sedgwick County, Kansas lying west of the west line of Northridge Plaza Addition, Wichita, Sedgwick County, Kansas, further described as:

All of Reserve "A", Ridge Addition, Wichita, Sedgwick County, Kansas, together with that part of Lot 6, Block B, and Lot 15, Block C, in said Ridge Addition, and that part of Lakecrest Cir. as dedicated in said Ridge Addition lying north of the following described line: Beginning at the NW corner of the S 1/2 of the SE 1/4 of said Sec. 28, said NW coner also being a deflection corner in the west line of said Lot 6; thence N89°58'41"E along the north line of the S 1/2 of the SE 1/4 of said Sec. 28, 378.61 feet to the deflection corner in the east line of said Lot 15, and there ending.

SECTION 2. That if any part or portion of this ordinance shall be held or determined to be illegal, ultra vires or void the same shall not be held or construed to alter, change or annul any terms or provisions hereof which may be legal or lawful. And in the event this ordinance in its entirety shall be held to be ultra vires, illegal or void,

then in such event the boundaries and limits of said City shall be held to be those heretofore established by law.

SECTION 3. That the City Attorney be and he is hereby instructed at the proper time to draw a resolution redefining the boundaries and limits of the City of Wichita, Kansas, under and pursuant to K.S.A. 12-517, et seq.

SECTION 4. This ordinance shall become effective and be in force from and after its adoption and publication once in the official city paper.
