



2019 Water Conservation Rebate Program DUAL FLUSH TOILET CONVERSION KIT REBATE

Dual Flush Toilet Conversion Kit Rebate: \$50.00 for newly purchased and installed dual flush toilet conversion kit that allows for choice in toilet water amounts flushed.

Rebate is available for all customers having active accounts with the City of Wichita Public Works and Utilities for delivery of potable water.

Specifications

The dual flush toilet conversion kit must allow for a ½ or full flush depending upon whether it is liquid or solid waste that is to be removed from toilet bowl. Only dual flush conversion kits, such as One2Flush, Dual Flush Pro, HydroRight, Fluidmaster Conversion Kit, etc. are eligible for the rebate. Trade names used here are as examples and are **NOT** recommendations. Early-close toilet flappers aren't eligible. Kits must be installed in older, less efficient toilets (1.6 or 3.5 gallons per flush, etc.)

Instructions

- The dual flush conversion kit must be purchased and installed between Jan. 1, 2019 and Dec. 31, 2019. Rebate is available on a first come first served basis, subject to funds availability.
- Mail the rebate application along with the required information to the address at the bottom of this page. You have 90 days after date of purchase in which to mail the application and required information for the rebate.
- Original copies of required information must be provided to verify purchase and installation. *Failure to provide the required information will result in the rebate request being denied.*
- Required information **must** accompany the application and this includes:
 1. Original invoice or sales receipt showing date and place of sale, date of installation, along with an itemized description of purchase and cost of item. Original installation receipts must be provided if installation is not completed by company of purchase. Carbon copies count as the originals. Online purchases, submit printout of final invoice and original packing or delivery slip. Photocopies will not be accepted.
 2. Original proof of purchase with complete barcode, if self-installed.
- An inspection may be required and the dual flush conversion kit must be properly installed in the toilet and functioning well at the time of inspection.
- There is a limit of 5 qualifying devices per active Water Utilities account, mixed or matched.
- The old toilet flushing mechanism must be properly disposed of in a manner that will prevent its reuse. Please recycle it if at all possible.
- Rebate amount will not exceed the actual purchase price of dual flush conversion kit, and excludes taxes and costs of installation.
- Rebates will be credited to applicant's water utility account.
