Rebate Terms

- I have read, understand and agree to the following:
- Rebate is available for any person connected to Public Works & Utilities potable water supply within the Wichita city limits. Account must be active at the address of installation. **Name on the utility account must match the name on this rebate application.** New Construction is not eligible for rebates.
 - Devices must be purchased between January 1, 2019 and December 31, 2019. Rebate application must be postmarked no later than 90 days after the purchase of the qualified products.
 - Original sales receipt or invoice showing itemized description, cost for the rebated item(s), date and place of sale, and date of installation if work is done by a contractor, must be provided with the application. Original installation receipts must be provided if installation is not completed by company of purchase. Carbon copies of receipts count as the original receipt. **Photocopies will not be accepted.** Original proof of purchase with complete barcode must be included for self-installed devices. For online purchases, submit printout of final invoice and original packing/delivery slip. If you need the original receipt(s) returned, please enclose a self-addressed, stamped envelope with your rebate application.
 - For rain barrels – a picture of the installed rain barrel must be included.
 - For rain sensors – a picture of sensor mounted above ground in an unobstructed location (e.g., no overhanging vegetation, building structures, etc.) must be included with application.
 - For toilets and urinals – verification of building/house built before 2005 must be completed.
 - The installed water conservation device(s) must meet the water-efficient specifications found at www.savewichitawater.com.
 - I understand when my application is processed a representative from the City of Wichita may contact me to verify the installation of the device(s), request additional proof of installation, and even perform a site visit before my rebate is issued. By submitting this application I am agreeing to any post-installation verification.
 - In accepting this rebate, I understand that qualifying items are selected on the basis of water efficiency only. The City of Wichita does not endorse specific brands, products or dealers; nor does it guarantee materials, workmanship, performance or durability of the qualifying items.
 - I understand that no rebate will exceed the purchase price of the item(s). Sales tax and labor charges will not be rebated. Rebate will be in the form of a credit to my Water Utility account and may take up to 8 weeks for approval. A maximum of five items will be eligible for rebates per water premise account.
 - Installation of any rebated device, appliance or fixture is my sole responsibility, as is the determination of the adequacy and compatibility of the existing plumbing system and compliance with the City of Wichita plumbing code. I understand that the City of Wichita assumes no responsibility or liability for any damage that may occur to my property as a result of participation in this program. I also understand that due to circumstances beyond its control, the City of Wichita cannot guarantee that installation of rebated fixtures or measures will result in lower utility costs.
 - Old appliances and/or toilets must be disposed of in an approved and appropriate manner that will prevent further use or reuse of the old device.
 - I understand that the City of Wichita reserves the right to amend and/or discontinue this program without notice. Any future year's program will be adjusted to current standards.
