

HOW TO OBTAIN A COPY OF A POLICE REPORT

1. YOU MAY ACCESS TRAFFIC ACCIDENTS ON-LINE

Available at www.wichita.gov/accident
(PDF Viewer is required)

Please be prepared with the following information:

Incident/Case Number (The year of the case plus six digits after the "C"; i.e. 07C000531)
Driver's first name, Driver's last name and street name
Date and time of Accident
Visa or MasterCard for payment
Email address for electronic receipt and summary of purchase

Accident Reports will be available within 10-15 working days of the incident.
Accidents over one (1) year old and accidents associated with any type of criminal case are NOT AVAILABLE.

2. YOU MAY MAIL IN YOUR REQUEST

Full name, DOB and Social Security number of person(s) involved
Date and time of Accident or Incident
Location of Accident or Incident
Self-addressed envelope
Address where copy of report is to be mailed OR

Email address where copy of report can be sent (ACCIDENT REPORTS ONLY-
PDF Viewer is required)
Include Check or Money Order for copy of report issued to CITY OF WICHITA

Please be prepared with the following information:

Incident/Case number (The year of the case plus six digits after the "C"; i.e. 07C000531)
Full name, DOB and Social Security number of person(s) involved
Date and time of Accident or Incident
Location of Accident or Incident
Address where copy of report is to be mailed OR
Fax number where copy of report is to be faxed OR
Email address where copy of report can be sent (ACCIDENT REPORTS ONLY-
PDF Viewer is required)
Visa or MasterCard for payment

4. YOU MAY GO TO CITY HALL, 455 N. MAIN, 5TH FLOOR - Police Records
(Open Monday through Friday, 8:00 am to 4:30 pm, Closed Weekends and Holidays)

Please bring with you the following information:

- Incident/Case number (The year of the case plus six digits after the “C”; i.e. 07C000531)
- Full name, DOB and Social Security number of person(s) involved
- Date and time of Accident or Incident
- Location of Accident or Incident
- Copy of photo ID (may be required)
- Payment may be made by Check, Money Order, Cash, Visa or MasterCard

THE COST FOR REPORTS ARE AS FOLLOWS:

May require up to 10 working days for availability.

- Traffic Accident - \$16.00
- Media Copy of Case- \$10.00
- Clearance Letters (**REQUIRED**: Copy of photo ID with date of birth) - \$15.00
- Criminal History Background Check - \$15.00
- Motion For Production Of Records - \$15.00

Reports will be available within 2-10 working days of the incident.

Accident Reports will be available within 10-15 working days of the incident.

There is *no charge* for a MEDIA copy of a report obtained by the “victim” or “reporting party” on the case.
