Dangerous Dog Definition:

Level 1-Any attack as defined by Section 6.04.010 or bite in an aggressive manner that pierces the skin; or any attack or bite subsequent to being deemed dangerous or potentially dangerous on a prior occasion. The designation can be removed after 36 months at the discretion of the Animal Services Supervisor or his/her designee.

Level 2- Any bite that requires medical attention; or any bite that includes deep punctures or bruising even when no medical attention is sought; or any attack or bite incident involving predatory aggressive behavior toward a human or other domesticated animal while running at large, including, but not limited to: chasing, stalking, circling, inhibiting movement, predatory or aggressive pack behavior; or any bite subsequent to being deemed dangerous or potentially dangerous on a prior occasion. The designation can never be removed for a Level 2 dog.

REQUIREMENTS:

- Owner shall provide a copy of the current City of Wichita Dog License along with application.
- Owner shall allow Animal Services access to the property where the dangerous animal is being harbored for inspections and to insure compliance for the duration of the life of the animal.
- Owner shall be required to implant a microchip into the dangerous dog traceable to the dog and the current owner. Upon completion of the implanted microchip, the owner must provide documentation to Animal Services. Failure to provide such documentation is a misdemeanor.
- Owner must have a secure enclosure approved by Animal Services. It must be adequately lighted and kept in a clean and sanitary condition.
- Owner must not allow the dangerous dog outside the secure enclosure, as defined in section 6.04.010, unless restrained by a chain or leash, no more than four (4) feet in length, and under physical restraint by a person who is eighteen years or older and possesses sufficient physical strength to control the dog.
- Owner shall display in a prominent place at the entrance to his/her premises a sign purchased from Animal Services indicating there is a dangerous dog on the premises. An additional sign purchased from Animal Services is required to be posted on the secure enclosure in which the dog is harbored.
- Owner must securely muzzle the dog if allowed outside the secure enclosure. The muzzle shall be made and used in a manner that will not cause injury to the dog, but shall prevent the dog from biting any human or animal.
- Owner shall notify Animal Services in writing a minimum of seven (7) days prior to any change in the address of the owner or location of the dog.
- Owner may be required to:
 - Attend an approved education course, canine aggression workshop, or management plan
 - Sterilize the animal in question within 30 days
 - Provide safety equipment
 - Carry liability insurance in the amount of at least \$100,000.00
- Failure to comply with any orders of the Supervisor of Animal Services, designee or any factfinder related to a dog being deemed dangerous or potentially dangerous is a misdemeanor and is punishable in accordance with Section 6.04.190(a).

I have read and understand the above requirements pertaining to the registration of a Dangerous Dog and agree to comply with all requirements set forth by applicable ordinances and policies established by the City of Wichita. I agree to allow the Supervisor of Animal Services or his/her designee access to the property where my dog is owned, kept, or harbored for the purpose of inspection and verifying compliance with the regulations and ordinances pertaining to proper animal care and maintenance. I also understand that if my previously determined Dangerous Dog is found running at large, attacks, or inflicts injury upon any person, the Judge of the Municipal Court shall order the dog destroyed.
