

**OPEN SLED SNOW DAY EVENT**  
**Guardian's Liability Waiver, Release and Indemnity Agreement**

ON BEHALF OF MY MINOR CHILD/WARD \_\_\_\_\_, I HEREBY ASSUME ALL OF THE RISKS OF PARTICIPATING IN ALL ACTIVITIES ASSOCIATED WITH THIS RECREATIONAL EVENT. I, the parent/guardian, certify and agree that my child/ward is physically fit, has sufficiently prepared or trained for participation in this activity, and has not been advised not to participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my child/ward's participation in this activity. I further acknowledge that I have familiarized myself with the description of the activity, understand the hazards and my child/ward's personal limitations, and knowingly assume all risks. My child's/ward's participation in this activity is purely voluntary and I elect to allow his/her participation in spite of these risks. In consideration of my child/ward's participation in this activity, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows:

I WAIVE, RELEASE, AND DISCHARGE from any and all liability the City of Wichita, its agents, officers and employees, for my child/ward's death, disability, personal injury, property damage, loss of any kind, or actions of any kind which may hereafter occur to my child/ward and/or me resulting from his/her participation in this activity.

I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the City of Wichita, its agents, officers and employees from any and all liabilities or claims made as a result of my child/ward's participation in this activity, whether caused by my child/ward's own actions or inactions, my own action or inactions, or the actions or inactions of the City of Wichita, its agents, officers and employees, or the actions or inactions of other participants in this activity.

I authorize and give my consent to the City of Wichita, its employees, agents, or volunteers to photograph/video my child/ward or me and without limitation, to use such photographs /video in connection with promoting/advertising the programs of the City of Wichita without consideration of any kind.

I HAVE READ AND UNDERSTAND THE ABOVE WAIVER AND RELEASE AND AGREE TO BE BOUND BY ITS TERMS. I HERBY CERTIFY THAT I AM THE PARENT /GUARDIAN OF THIS MINOR CHILD AND THAT I HAVE THE LEGAL RIGHT TO ALLOW THIS CHILD TO PARTICIPATE IN THIS ACTIVITY.
